

Fixed Route Bus Ridership - Service Type: Weekday




Fixed Route Bus Ridership

- Fixed Route Bus ridership declined by 61%
- Earthquake had minimal effect on Fixed Route Bus



FrontRunner Ridership - Service Type: Weekday




FrontRunner Ridership

- FrontRunner ridership declined by 77%
- Longer distance commuters show larger drops than local routes
- Earthquake moderately affected FrontRunner ridership



Light Rail Ridership - Service Type: Weekday




Light Rail Ridership

- Light Rail ridership declined by 64%
- Earthquake dramatically affected Light Rail ridership



Paratransit Ridership - Service Type: Weekday




Paratransit Ridership

- Paratransit ridership declined by 78%
- Earthquake dramatically affected Paratransit ridership



UVX Ridership - Service Type: Weekday



UVX Ridership

- UVX ridership declined by 73%
- Earthquake had minimal effect on UVX

*Normal Weekday Ridership (Pre-Decline) is calculated by taking the average ridership of all weekdays between 2/11/2020 and 3/11/2020. All ridership is taken from unadjusted, preliminary data and is subject to change.



UTA Service Adjustments to Date

Suspended routes to closed work activity centers

- **606, 608**
- Suspended or reduced routes to closed ski resorts
 - 674, 675, 677, 880 (suspended); 953, 972, 994 (reduced)
- Suspended routes or trips to closed schools
 - 650, 919, 920 (routes); 455, 473, 626, 627, 640, 841, Red Line (select trips)





- Service Modifications
 - Maintain span of service on most routes
 - Adjust service frequency
 - Suspend some commuter bus routes



Weekday Service

• Fixed Route Bus

- Maintain span of service on most routes
- Adjust frequency of service on most 15 and 30-minute bus routes
 - Adjust UVX service from 6 to 15-minute service
- Suspend some commuter bus routes where alternative service is available

• Light Rail

- Adjust frequency from 15 to 30-minute service
- Commuter Rail
 - Adjust frequency from 30 to 60-minute service



Saturday Service

• Fixed Route Bus

- Adjust frequency of service on 15-minute bus routes to 30 minutes
 - UVX will maintain 15-minute Saturday service
- All other bus routes retain Saturday schedule

• Light Rail

- Adjust frequency from 20 to 30 minutes
- Commuter Rail
 - Maintain current Saturday schedule






- All bus routes retain Sunday schedule




Salt Lake/Tooele Service Modifications




